

**Assumption of Risk and Waiver of Liability Relating to COVID-19**

As part of the Power Up! conference taking place on October 13-15, 2021 at the Hyatt Regency in Wichita, Kansas, Interhab, Inc. is implementing enhanced COVID-19 safety procedures and protocols for your safety and the safety of other attendees, Interhab employees, and event staff.

**By signing below, you agree to the following safety procedures and protocols as a condition of your attendance at the Power Up! conference:**

- ✓ I understand that, while Interhab and the venue provider have implemented safety procedures to reduce the risk of COVID-19 infection while attending the conference, neither Interhab nor the venue provider can guarantee that I or other individuals who attend the Power Up! conference will not contract or be exposed to COVID-19, and I voluntarily assume that risk.
- ✓ I agree that, regardless of vaccination status or federal, state, or local guidance, I will wear an appropriate face covering while attending the Power Up! conference.
- ✓ I agree to maintain 6 feet of social distance whenever possible.
- ✓ I will frequently wash my hands and/or use hand sanitizer during the conference.
- ✓ I agree that upon my arrival at the conference, I will either: a) provide Interhab with proof that I am fully vaccinated (as defined by CDC guidance); or b) provide Interhab with the results of a negative COVID-19 test administered less than 72 hours prior to the start of the conference.
- ✓ Regardless of my vaccination status, I agree not to attend the event if I am experiencing any COVID-19 symptoms during or immediately prior to the Power Up! conference.
- ✓ Given the constantly evolving nature of the COVID-19 pandemic, I agree that I will follow these safety procedures and any additional or different safety procedures imposed by Interhab and/or the venue provider as part of my attendance of the Power Up! conference.
- ✓ I understand that my failure to follow required protocols at the conference is grounds to be excluded from the event, and I agree to exit the event, without protest or refund, upon request by Interhab or the venue provider due to my refusal to follow said protocols.

**Waiver of Lawsuit/Liability: I release and waive my right to bring suit against Interhab, Inc. and its owners, officers, directors, board members, managers, agents, employees, and volunteers in connection with exposure, infection, and/or spread of COVID-19 related to attending the Power Up! conference at the Hyatt Regency in Wichita, Kansas on October 13-15, 2021.** I understand this waiver means I give up my right to bring any claims, including for personal injuries, death, disease, property loss, or any other loss, and I give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen. I understand the laws of the State of Kansas apply to this agreement.
