A day does not go by that Sheri does not make a huge difference in the lives of persons-supported, her staff and everyone at Cottonwood. Sheri began her career with Cottonwood right out of high school as a DSP in our Life Enrichment area which supports people with significant needs. While her work experience has remained in the Life Enrichment area over her 28+ years at Cottonwood, this tenure should in no way imply that her work was stagnant. She has been promoted from DSP to Team Lead to Supervisor to Coordinator to Sr. Coordinator. With each promotion came new challenges and opportunities and in true Sheri-style, she faced them all with a calm energy to get things done!

Sheri embodies the values of empathy, respect, and inclusion in all aspects of her work. Through innovative programs and initiatives, she has provided invaluable support and resources to persons-supported, families and staff, to aid persons-supported to achieve their full potential and lead fulfilling lives. Her tireless efforts developing Cottonwood's capacity to face these huge challenges brought about by the pandemic strengthened the organization in so many areas and Cottonwood emerged from these times a stronger, more nimble and flexible organization.

Over the past year, Sheri has worked tirelessly to build a new day activity program at Cottonwood called CORE (Community, Outreach, Recreation, and Enrichment). Cottonwood had not implemented a new day service in decades. Sheri led a team to address needed changes due to the implementation of Final Rule and designed and deployed an amazing, innovative and creative community-focused program which has had huge success, both for persons-served and Cottonwood.

In addition, Sheri consistently demonstrates kindness, patience, and maturity in her interactions with persons-supported and their families. She is never defensive, listening to everyone's point of view and working collaboratively to solve the problem.
